State of California Expected to Extend Current Shelter-in-Place Order

The State of California is expected to announce on Saturday, January 9, that the current regional Shelter-in-Place Order will remain in effect until the Bay Area Region meets or exceeds 15% ICU capacity. Currently, the ICU capacity in our region is at 3.5% capacity. Alameda County cannot act on its current Order until the State formally announces the status of our region.

The County also announced that the region is experiencing the greatest surge in COVID-19 cases since the start of the pandemic. All residents are encouraged to remain at home, and to wear a mask whenever going out for essential needs.

California Small Business Relief Grant Update

The deadline for Round One of the State's Small Business Covid-19 Relief Grant program has been extended to January 13, 2021. This is not a first-come, first-serve application process or rolling approval process - all eligible applicants will be considered for the grant at the close of Round One on January 13, 2021 at 11:59 p.m. The application period for Round Two has not yet been announced.

If you already started your application, you should have received a new password. Your password prior to 1/6/2021 can no longer be used to enter the system; however, usernames did not change.

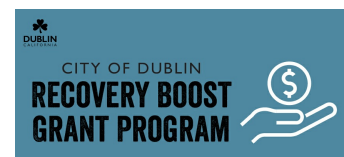


While current regulations will keep this event focused on takeout and delivery, VTV is excited to do whatever they can to promote our restaurant community during these challenging times.
