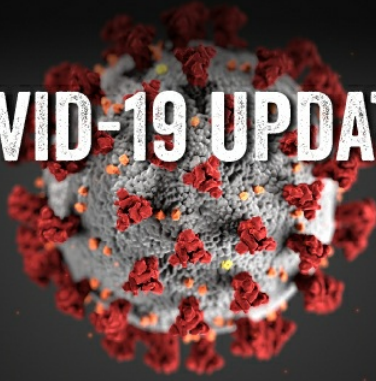
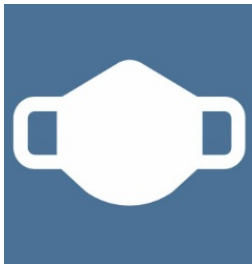

## Alameda County Face Covering Order Amendment FAQ



Alameda County has developed an [FAQ](#) for the Amendment to the [Indoor Face Masking Mandate](#) that went into effect on November 1, 2021. This [FAQ](#) provides clarification regarding the [masking requirements for fully vaccinated people in limited indoor settings](#) including minimum safety precautions, capacity limit, information required to be collected by the employer or host, etc. The [FAQ](#) is currently available in English and will be available in additional languages soon. ## Alameda County Health Officer Order Issues New COVID-19 Vaccination Order

On November 9, 2021, the Alameda County's Health Officer ordered that all 9-1-1 ambulance support, non-emergency medical transport, and first responders (including law enforcement officers and fire personnel) who enter High-Risk Health Care Facilities to be fully vaccinated against COVID-19 by December 21, 2021. The Health Order applies to individuals in Alameda County who enter high-risk health care facilities, as described in the State of California's [Health Order of August 5, 2021](#). Individuals who are not fully vaccinated by December 21 must wear masks while in the presence of patients or residents and must test for COVID-19 weekly.

## CA Department of Fair Employment and Housing Releases Guidance for Businesses on COVID-19 Safety Measures

California's civil rights protection and enforcement agency, the Department of Fair Employment and Housing (DFEH), issued guidance to California businesses regarding COVID-19 safety precautions. The guidance provides businesses with important information to safely operate, such as requiring masking or proof of vaccination to enter the premises, while also giving clear guidance on how to implement such measures consistent with California's civil rights laws. ## Small Businesses Can Apply for Loans Through California Rebuilding Fund

The California Rebuilding Fund is offering low-interest loans to California's small businesses that have been hurt

by the pandemic and associated disruptions, and will be targeted especially at businesses in economically disadvantaged or under-banked parts of the state.

- The fund is not offering forgivable loans and is not associated with the federal Paycheck Protection Program or any other program of the Small Business Administration.
- The loan must be paid back, and in most parts of the state, it will also include interest.
- Loan terms are three to five years.
