
## Special Event Food Services Requirements

You are responsible for ensuring that all recyclable and compostable materials are diverted from the landfill, as required by California law (SB 1383). Waste reduction, recycling, and composting help minimize the creation of greenhouse gases and save valuable space in the landfill.

Practice 3 stream sorting within your booth. Please put your 3 bags out at the end of the event for staff to pick up along with flattened cardboard boxes. There will also be 3 stream sorting stations with signage throughout the event.



# STORMWATER BEST MANAGEMENT PRACTICES Food Service Vendors at Special Events

You are responsible for identifying and implementing Best Management Practices (BMPs) to prevent discharge to the storm drain system. The storm drain system flows directly to local creeks, without any treatment. The following examples of BMPs have been developed to assist you in establishing your event plans. **By following appropriate BMPs, fines and cleanup costs resulting from an illegal discharge to storm drain may be avoided.**

## CREEK AND STORM DRAIN PROTECTION

### PREPARATION

#### Before the event, take these steps:

- Make spill kits available that are comprised of paper towels, cloth towels, and an absorbent such as kitty litter or sand. Also have a broom and dustpan on-hand to sweep up absorbent in the event of a spill.
- Have a plan to manage cooking oil and grease that is generated on site. Cooking oil and grease must be disposed in an appropriate receptacle, not in the on-site waste bins.
- Train employees who will be working at the event on proper cleanup procedures.
- Spills must be captured and prevented from entering storm drains using your spill kit.



### CAPTURE

#### Once your event has ended, clean up the area:

- Sweep up litter, trash, and debris and discard in a trashcan.
- Use an absorbent to clean liquid spills. Sweep up the spent absorbent and put it in a waste bin. Never use a hose to wash away the liquid spills.
