Low-Interest Loans for Small Businesses



The **California Rebuilding Fund (CRF)** has opened its **low-interest loan program to small business owners**.

CRF is a loan program to support California's small businesses - especially those located in economically disadvantaged and historically under-banked areas of the state. The CRF is a public-private partnership offering loan funding from private, philanthropic, and public sector

sources to address the financing needs of California's small businesses, not only as they recover from the COVID-19 crisis, but over the long-term. Please note that this program is not associated with the federal Paycheck Protection Program (PPP) and the loans are not forgivable in part or whole.

US Small Business Administration Microloan Program

The Microloan program provides **loans up to \$50,000** to help small businesses and certain not-for-profit childcare centers start up and expand. Microloans can be used for a variety of purposes that help small businesses expand, rebuild, re-open, repair, enhance, or improve your small business. Examples include:

- Working capital
- Inventory
- Supplies
- Furniture
- Fixtures
- Machinery
- Equipment

- **Ascent** - A free learning platform for women entrepreneurs to help you grow your business.
- **Kiva** - A non-profit that expands access to capital for entrepreneurs by connecting small business owners to 0% interest crowdfunded loans.
- **Working Solutions** - Provides affordable loans ranging from \$5,000 - \$100,000 paired with free business consulting support.

- **Accion Opportunity Fund** - Offers loans ranging from \$5,000 - \$100,000 as well as educational resources, coaching, and support networks in English and Spanish.
- **Microsoft for startups** - A free hub for startups designed to support all founders by bringing together the technology, guidance, and support needed to hit your next milestone.
- **Grow with Google** - Offering workshops to equip Black and Latinx small businesses with digital skills to reach new customers, thrive online, and grow.

State and Federal Tax Credits for Hiring Employees

The State and Federal government are offering several **tax credits for hiring**, including:



- **New Employment Credit** - for hiring Qualified Full-Time Employees, such as people who were unemployed for longer than six months immediately preceding hire, Veterans separated from U.S. Armed Forces in the preceding 12 months, Earned Income Tax Credit recipients, Ex-offenders, and recipients of CalWORKS or county general assistance.
- **Homeless Hiring Tax Credit** - for hiring currently or recently homeless people or those who are receiving services from a homeless services provider.
- **Work Opportunity Tax Credit (WOTC)** - for hiring American job seekers who have consistently faced barriers to employment, such as veterans, ex-felons, summer youth employees, SNAP recipients, long term unemployment recipients, and more.

CalOSBA Announces \$35 Million California Dream Fund to Expand Small Business Assistance in California



The California Office of the Small Business Advocate (CalOSBA) announced the **California Dream Fund Program** (Program), a \$35 Million grant program that will provide microgrants to seed entrepreneurship and small business creation in California. To qualify for the Program, small startup businesses must complete a rigorous training and consulting program with one of 17 technical assistance centers selected from CalOSBA's Technical Assistance Expansion Program (TAEP) network. Businesses that complete the program and qualify for the grant will be eligible to receive a microgrant of up to \$10,000.
