## **DECLARATIONS**

I certify that I have the authorization of the Property Owner to file this request for a Parking Lot Pavement Repair & Restriping permit, which includes a Site Development Review Waiver and Site Work Permit. I understand that the proposed modifications require either Site Development Approval or Site Development Review Waiver, and that said that waiver may be approved by the Dublin Community Development Director, depending upon whether the proposal constitutes a minor modification to the project pursuant to Section 8.104.030 of the Dublin Zoning Ordinance. I further acknowledge that the Community Development Director may transfer hearing jurisdiction and permit type at any time. I further understand that the proposed modifications shall not be started until all appropriate City approvals are received.

Indemnification. Permittee shall indemnify, hold harmless, and defend the City (including its elected officials, officers, agents, and employees) from and against any and all claims (including litigation, demands, damages, liabilities, costs, and expenses, and including court costs and attorney's fees) resulting or arising from performance, or failure to perform, under this application (except only for those claims arising from the City's sole negligence, willful misconduct, or active negligence, as defined by California Civil Code section 2782). This permit shall not be assigned or transferred.

Applicant is hereby made to the Building Official for a permit subject to the conditions/restrictions set forth on this application and the following: 1) Construction activity is prohibited between the hours of 6pm and 7:30am and on Weekends and Holidays. After hours, weekend, and holiday work subject to City approval and will require submittal of a Saturday/Holiday permit application. 2) The approved plans and Permit Inspection Card shall remain on the job site. 3) Final inspection of the work authorized by this permit is required. 4) Sufficient dust and noise control shall be employed at all times.
