Businesses in the Tri-Valley who apply will receive local preference points as part of the review.

The program is anticipated to launch in April 2023.

CDTFA Emergency Tax or Fee Relief

Emergency tax or fee relief is available from the California Department of Tax and Fee Administration (CDTFA) for taxpayers who have been directly affected by disasters declared as state of emergencies within California.

U.S. SBA Disaster Loan Assistance

Disaster assistance is available for businesses and nonprofits to help communities recover after recent storms. The U.S. Small Business Administration (SBA) offers low-interest disaster loans to help businesses and nonprofits recover from declared disasters. SBA also provides eligible small businesses and nonprofit organizations with working capital to help overcome the economic injury of a declared disaster. California Storm Victims Qualify for IRS Tax Relief

The IRS is offering relief to any area designated by the Federal Emergency Management Agency (FEMA). This means that individuals and households that reside or have a business in Alameda and other counties qualify for tax relief. The tax relief postpones various tax filing and payment deadlines that occurred starting on January 8, 2023. As a result, affected individuals and businesses will have until May 15, 2023, to file returns and pay any taxes that were originally due during this period.
