Citywide Outdoor Seating Design Guidelines

City of Dublin
September 19, 2023

Resolution No. 104-23



The City Council approved the Citywide Outdoor Seating Design Guidelines at the September 19, 2023, City Council meeting.

The Design Guidelines help to facilitate the design of permanent outdoor seating within parking lots for eating and drinking establishments.

In addition, Design Guidelines ensure that outdoor seating within parking lots is aesthetically pleasing, provides a high-quality environment for patrons and is appropriately designed for the location. The Design Guidelines provides a framework intended to provide design direction for restaurant operators and design professionals while encouraging innovation and creativity.

Additionally, the City of Dublin has the Outdoor Operations Grant Program that is available for eligible businesses with approved Planning permits for outdoor seating that includes:

- Grants for outdoor operations improvements: This funding can be utilized to enhance your outdoor seating area and make necessary improvements.
- Permit fee assistance: This covers the staff costs associated with processing permits related to outdoor seating. It can be beneficial for businesses that may not wish to pursue grant funding but still need assistance with the permit fees.

Grant funds are provided on a first-come, first-served basis once the outdoor seating permit is approved.

The **Franchise Fund** is a four-month grant program created by the Golden State Warriors, United Airlines, and the Western Region Minority Supplier Development Council aimed to prepare minority small business owners to work with multinational corporations. Graduating businesses will receive the certification they need to get exposure, help their communities, and take advantage of future business opportunities. The goal of Franchise Fund is to support Bay Area minority-owned small businesses by providing resources to become certified as Minority Business Enterprises.

US SBA Lending Program Improves Access to Capital

The U.S. Small Business Administration (SBA) began implementing additional policies aimed at **expanding small business access to capital** by modernizing SBA's signature 7(a) and 504 Loan Programs. The updates also address long-standing persistent capital access gaps for rural, veteran, women, and minority-owned businesses.

The loan program improvements will increase small businesses' ability to access funding to start up and grow through a broader network of lenders with streamlined lender procedures. The new, simplified guidelines for lenders are part of three updated Standard Operating Procedures (SOP), including updated origination policies and procedures, lender participation requirements, and 7(a) loan servicing and liquidation requirements. For example, SBA is providing additional flexibility in credit criteria for loans under \$500,000 to support SBA loans in reaching more credit-worthy small businesses.

IRS Temporarily Pausing Employee Retention Tax Credit

The Employee Retention Tax Credit is a refundable tax credit for businesses and tax-exempt organizations that had employees and were affected during the COVID-19 pandemic.



To protect taxpayers from scams, the Internal Revenue Service has placed a moratorium on new claims through 2023 to allow the IRS to add more safeguards to prevent future abuse and protect businesses from predatory tactics.
